**INVITATION FOR EXPRESSION OF INTEREST
FOR EMPANELMENT OF AUTHORITY ENGINEERS**

Project Number and Title:

1. Maharashtra State Infrastructure Development Corporation Ltd (MSIDC)(the “Authority”), A Government of Maharashtra Undertaking is engaged in development of infrastructure in Maharashtra and as a part of endeavor, the Authority has decided to undertake road development works on EPC mode in the State of Maharashtra. through 146 Packages spread all over in the State.
2. MSIDC now invites expression of interest (EOIs) from eligible consulting firms for empanelment of Consulting Services as Authority Engineer (AE) under the proposed project, over a period of 30 (Thirty) months. The services may be extended as per requirement with mutual consent. The Authority Engineer services will broadly involve (i) Construction supervision systems and services to MSIDC. (ii) They would provide design support to MSIDC whenever required. (iii) The AE will also assist the in complying with the procedures of the Government for effective project implementation. The detailed scope of work shall be as per Terms of Reference (TOR).
3. The packaging of AE shall be decided by MSIDC separately and will be indicated in the RFP. The indicative size of the AE package will be approx. 500 kms or INR 4000 Crores.
4. The Consulting firm should have experience of supervision of projects (2L/4L roads/highways, expressways with rigid/flexible pavement) and carried out similar works of 500 Kms or 4000 crores in last five years.
5. The Consulting firm may submit the EOI with maximum number of Two teams along with the details of Key persons in the excel sheet attached with TOR. Minimum Team composition is as indicated in TOR. The duplication of Key Experts in any Team will result in disqualification from the selection procedure.
6. Interested national / international engineering firms must be from ADB member countries having prior experience in providing consulting services on externally financed similar projects in the region or national level. Consulting firms, may form a joint venture (JV) or an association for expressing interest. When expressing interest, a JV or an association must nominate one firm as the lead firm who will interact directly with MSIDC as the appointed representative of the JV or association.
7. Interested consultancy firms may submit their expression of interest for all packages. After EOI evaluation, if the firm gets shortlisted for all packages, RFP will be issued for all the packages. Firms can submit their bid

for all eligible packages. However, a firm will be allotted maximum Two package considering least cost to Government.

8. The EOI notice is available for viewing/ downloading on www.mahatenders.gov.in
9. All eligible interested Consulting firms who want BTO participants in the EOI process should compulsory get enrolled on tendering portal www.mahatenders.gov.in
10. In the appropriate category applicable to them.
11. The EOI must be submitted online.
