(ii) Passing Score for Stage-1 shall be 75 out of 100 points. (iii) The consultants passing Stage-1 (Technical Qualification) shall only be qualified for Stage-2 (Financial Qualification) qualification. (iv) The S₁ bidder after the evaluation of Stage-1 and Stage-2 shall be appointed as the consultant for the subject work.
